I have worked for Credit Suisse since May 1997 and Mike Shillaker used to work here. He left to go and work for UBS and then came back to Credit Suisse.

We work in the same office, which is an open plan office.

Working with us Scottish, Liam, Alessandro Malinda, Amy and Nicola.

Mike is an MD in the company and we have never socialised outside of work.

Mike is very well respected by his clients but his management skills have got to be criticised. He is not supportive of his staff and I have seen him shout at other staff.

His behaviour is unacceptable but it has never been directed at me.

I have spoken to management about his behaviour towards Hannah Kirby. She was unhappy with his attitude towards her, he

would not talk to her, so she moved to the 2nd Floor to escape his bullying and then she left the company to Morgan Stanley.

I have never seen him behave badly towards Amy, they have no reason to interact with each other, and I cannot recall either of them talking badly of each other.

On Friday the 16th of April 2010, Amy came to work and I know that she had a meeting with a client who had not been impressed with the service he was getting from Credit Suisse, and Amy had on a very nice dress she looked smart, there was no skin showing, she looked very smart and when she came back from the meeting, she was very happy how it had gone.

Within the office comments were made about how good Amy looked, I do not remember Mike making comment.

Mike mentioned that we should go out as a team for a drink, and as my family were away I said to Amy, lets go along.

The others left before Amy and I, and Sathish came back and told us Mike had sent him to get us.

We left together and I think it was about 6pm-630pm and we went to 'Garnoy & Barrow' just by our office building.

Subs was at the bar, Mike and the rest were sat

outside on a wall by some stairs. Subs had cash from Mike to buy the drinks and I ordered a bottle of beer and Amy had a small glass of white wine.

We carried our drinks out and sat with the rest of the group.

I was sat next to Mike and on the opposite wall there was Amy and Moina sat on the wall. Subs was standing closest to the bar area and at the bottom of the stairs. Arthur was also standing.

Mike was telling me about his divorce.

Mike sent Subs in to get more drinks and he came out with a number so the waiter could find us.

The waiter came out with the drinks and they were given out. I saw that Amy had a ~~upper~~ glass of white wine, and as far as I could tell she drank half of it before I left at about 8pm.

During this time I did not see Mike or near Amy's drink or even near Amy. He stayed sat on the wall.

I remember him encouraging her to take her coat off, which she did, she gave the impression to me that she thought it was fun. It was not warm that night.

I was the first to leave and everyone appeared

sober when I said my Good byes
I heard nothing more until the Saturday, at about
9pm when I checked my home email and found
an email from Amy say, 'Something terrible happened
last night please call me, she put her mobile
number on the email.

I called her and she told me that she thought
she had been drugged that had Mike had raped
her and told her he wanted to get a hotel
room and that she was bruised.

I just listened and when I went to work on
Monday morning, Amy showed me the bruises on
her elbow and on her legs, she told me that
she had been to the police and given a urine
sample.

She asked me if I could send out an email
on her behalf warning members of staff, that
there had been a incident in Amy and Barrow
and someone had been drugged and she wanted
staff to be aware.

Amy was scared she was going to lose her
job.

I have not spoken to Mike about this.

Amy did forward me an email from Mike
saying he ~~wasn't~~ hadn't spoken to anyone about what
Amy and I do not see each other outside
of work.

I have never seen Amy have physical contact
